## MEMBERSHIP AGREEMENT

Sandy Shores Wellness Center's goal is to provide a clean, safe, and comfortable atmosphere for its members to enhance their wellness and to strive to reach fitness goals. To this effect, the following rules have been established:

### GENERAL RULES

- Members under the age of 16 must be accompanied by an adult. Adults are responsible for the conduct of minors in their care.
- Only the main entrance will be utilized for entering and leaving the center. All other exits are for emergency purposes only.
- Please use respectful behavior and language toward other members and staff at all times.

### POOL FACILITY RULES *(please note that open swim hours vary)*

- When the pool room is closed for classes, this includes showers, sauna, hot tub and pool.
- There is no lifeguard on duty, therefore, constant supervision of children is expected.
- No diving, running or "horseplay."
- No food or beverage other than water. Glass containers are prohibited.
- **Showers are mandatory** before entering the pool or hot tub. This includes re-entry to the pool or hot tub after use of the sauna or bathroom.
- Pool room will be closed if adverse weather (i.e. lightning) is present or imminent.
- No open wounds in the pool or hot tub, including those covered by bandages.
- If you are ill with flu-like symptoms, (nausea, diarrhea, vomiting etc.) please stay home.
- Water bells, noodles and any other pool-type toys must be put away after use.
- Items that are brought in (water shoes, approved toys, etc.) must be clean. Please do not bring items to the pool that you are using on the beach, sandbox, etc.

### Terms of Membership

Upon use of this facility, I shall receive the membership rights and privileges and agree to abide by all the rules, regulations, and policies of *Sandy Shores Wellness Center*, which are subject to change. Non-compliance may result in an involuntary termination of my membership. All center memberships that are terminated early (voluntarily or involuntarily) are subject to a \$129.00 cancellation fee.
